We refer to your official information request dated 13 March 2024 regarding BDC rates increases and associated queries re water services and infrastructure.

Please see your questions below, with BDC responses marked in red:

- What is your Council's proposed rates increase this year?
 19.7% total rates increase for the district—It will depend on what part of the region people live as to what their % is overall. Our total General rates movement is 16.7%
 - a. What proportion of that is for water services and water infrastructure?

 The breakdown for the water rates increases and infrastructure are as follows:

 Stormwater 0.9%, wastewater, 2.1% and water supplies is 6.9% total 10%
 - b. What proportion of any proposed rates increase is to service the debt for water infrastructure?

Stormwater 0.2%, Wastewater 0%, Water Supplies 0.4%, total 0.6% - this reflects the impact to rates for the incremental interest forecast to be paid on both internal and external borrowings for these activities in 2024/2025 compared to 2023/2024, BDC rates for depreciation for 2024/2025 any net cost of capital being capex + loan repayments less external and depreciation funding is budgeted to be funded by borrowings so forecast increases in loan repayments does not directly impact rates.

- 2. What proportion of any proposed rates is to service debt for water infrastructure?

 This would be the same answer as 1b
- 3. How much debt is your Council currently servicing for water infrastructure?
